## **Utility Board**

- Utility Board convened
- McCord Point Development: The easements on the north side of McCord Road corss a number of properties. One homeowner is interested in connecting to the sewer and is open to a voluntary annexation to accomplish it.
  - Mr. Eldridge: His property line is 41' from the CalAtlantic property. His home was originally 60 acres so part of his septic may be on the part of land now owned by CalAtlantic. He wants to hook on to the town sewer system. Mr. Witsman suggested a lateral line be run to Mr. Eldridge's property line and to waive the sewer availability fee. The Council is supportive of the idea but wants to see all the fees that are involved.
    - Motion by Dr. Burney to agree to waive the availability fee for Mr. Eldridge including the \$3,500 availability fee and survey fee up to \$1,000 on the condition that he voluntarily annex into town and dedicate the right of way according to our annexation policy. 2<sup>nd</sup> by Mr. Wood.
