# ORDINANCE AMENDING TRAFFIC CONTROL AT THE INTERSECTION OF NORTH PORT DRIVE AND WEST STREAM DRIVE IN THE TOWN OF McCORDSVILLE, INDIANA

WHEREAS, by ordinance duly passed, published, and currently legally in effect, traffic control at the intersection of North Port Drive and West Stream Drive in the Town of McCordsville, Indiana, was established whereby all vehicles traveling eastbound and westbound on West Stream Drive are to come to a complete stop at its intersection with North Port Drive and not proceed until it is safe to do so; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has received a recommendation from the Public Safety Committee that all traffic at said intersection be required to come to a complete stop and not proceed until it is safe to do so.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana that:

## **SECTION 1**

Vehicles proceeding eastbound and westbound on West Stream Drive, at its intersection with North Port Drive, shall come to a complete stop before proceeding into said intersection and shall not proceed until it is safe to do so.

#### **SECTION II**

Vehicles proceeding northbound and southbound on North Port Drive at its intersection with West Stream Drive shall come to a complete stop before proceeding into said intersection and shall not proceed until it is safe to do so.

### SECTION III

Any person violating this ordinance will be fined in the amount of \$50.00 for the first violation and \$75.00 for any second or subsequent violation which occurs within twelve (12) months of the previous violation.

#### **SECTION IV**

This Ordinance shall be in full force and effect from and after its passage and due publication and posting is required by law within the Town of McCordsville, Indiana.
