ORDINANCE AMENDING ORDINANCE NO. 111318A

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore established a McCordsville Trash Utility to provide trash collection services for one and two family residential users within the incorporated limits of McCordsville, Indiana; and

WHEREAS, upon recommendations of staff, certain modifications to Ordinance No. 111318A are required to comply with Indiana law and to make billing and collection of said trash utility user fees more efficient; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, acting as the Municipal Utility Board finds that the recommended amendments to Ordinance No. 111318A are in the best interest of the citizens of McCordsville, Indiana, and the efficient operation of the McCordsville Trash Utility.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Section II (a) shall be deleted in its entirety and inserted in lieu thereof shall be the following:

(a) The Trash Collection Fee shall be prepared and billed monthly. For users that do not occupy a location served by the Trash Utility on the first day of the month, or the last day of the month, their charges shall be prorated on a per diem rate calculated on the basis of thirty (30) days per month times the monthly rate and charge for users of the same type and category multiplied by the number of days in the month the user occupies the premises.

SECTION II

This Ordinance shall be in full force and effect from and after its passage and due publication.
