ORDINANCE AMENDING ORDINANCE NO. 121410, THE ZONING ORDINANCE FOR THE TOWN OF McCORDSVILLE, INDIANA

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore adopted Ordinance No. 121410 as the Zoning Ordinance, as amended; and

WHEREAS, the Town Council of McCordsville, Indiana, has, after a public hearing was held on _____, 2021, received a _____ recommendation from the McCordsville Advisory Plan Commission requesting an amendment to the Zoning Ordinance in order to rezone property from Residential - 3 (R-3) to Professional Business Office (CO);

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that Ordinance No. 121410, as amended, is hereby amended as follows:

SECTION 1. The real estate more particularly described in the attached Exhibit A is hereby rezoned to the CO zoning designation.

SECTION 2. Permitted Uses. The permitted uses are those uses listed in McCordsville Zoning Ordinance for the CO zoning district.

SECTION 3. Development Standards. The Town of McCordsville Zoning Ordinance, as amended, Subdivision Control Ordinance, as amended, and any other applicable Town Ordinance, as amended, shall apply to this property upon the effective date of this Ordinance.

SECTION 4. This Ordinance shall remain in full force and effect from and after its passage and posting as required by the law within the Town of McCordsville, Indiana.

SECTION 5. Introduced and filed on the ____ day of _____, 2021. A motion to consider on First Reading on the day of introduction was offered and sustained by a vote of __ in favor and __ opposed pursuant to I.C. 36-5-2-9.8.
