# RESOLUTION REGARDING WORTHLESS PERSONAL PROPERTY AND DISPOSITION THEREOF

WHEREAS, the Town of McCordsville, Indiana, by and through its wastewater utility is the owner of one Cummins Onan GenSet 125 KW generator with a model number of DGEA-338-0689 and a serial number of 990008692, Specification L; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana has been informed by the Public Works Commissioner that the utility no longer has use for the above-described generator and that it is of no value to the utility nor to the Town in general; and

WHEREAS, pursuant to I.C. 5-22-22-8(a) an item of personal property can be deemed worthless and may be demolished or junked; and

WHEREAS, pursuant to I.C. 5-22-22-8(b) an item is deemed worthless or no market value if the value of the property is less than the estimated cost of the sale and transportation of the property; and

WHEREAS, the Public Works Commissioner has been contacted by representatives of Ferris State College, being a technical college about receiving the aforementioned generator by way of donation for its students to study, work upon and learn about how generators of this type function and operate; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana believes it is in the best interest of its citizens and efficient management of its assets that said generator be junked by way of donation to Ferris State College.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of McCordsville, Indiana as follows:

### **SECTION I**

Pursuant to I.C. 5-22-22-8 the Cummins Onan GenSet 125 KW generator described above is hereby declared worthless.

### **SECTION II**

The Public Works Commissioner is hereby authorized to dispose of the generator as worthless property by allowing the unit to be removed by representatives of Ferris State

College from the generator's location on the Town's property owned by the Town of McCordsville, Indiana.

## **SECTION III**

This Resolution shall be in full force and effect from and after its passage in accordance with the law.
