ORDINANCE TO AMEND TITLE III, CHAPTER 31, § 31.01

WHEREAS, on the recommendation of staff and human resources consultants, it has been proposed that the current Employee Handbook as adopted by Ordinance No. 051209 and Ordinance No. 121211 and all amendments supplemental thereto, be replaced with a completely revised Employee Handbook; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana believes the adoption of the completely revised Employee Handbook is in the best interest of the efficient management of the personnel and staff of McCordsville, Indiana.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

SECTION I

Title III, Chapter 31, § 31.01 is hereby deleted and in its entirety insert in lieu thereof is the following:

The Employee Handbook, as previously adopted pursuant to Ordinance No. 051209 and Ordinance No. 121311 and all subsequent amendments thereto, are hereby repealed effective June 1, 2023 and in lieu thereof, there is adopted as the McCordsville Employee Handbook, which is attached hereto as Exhibit A and incorporated herein by reference into this Code as if fully set out herein.

SECTION II

This Ordinance shall be in full force and effective as of June 1, 2023.
