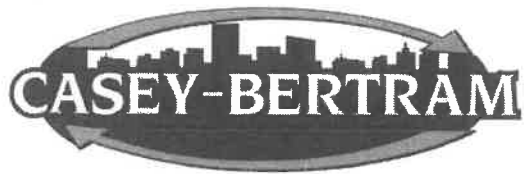

Includes:

- C-B will provide labor, equipment, trucking, dumpsters, disposal fees, and McCordsville permits (fees to be waived)
- C-B will coordinate all paperwork for permits, notifications, and inspections
- C-B will notify IDEM (10-business day waiting period prior to demolition per State code)
- C-B will cut, cap, and mark sanitary sewer line within 5' of the structure
- C-B will contact utility companies for demolition termination letters (water, gas, electric, phone)
- C-B will remove structure, slabs, foundations, trash, rough grade, seed, straw (Base bid)
- C-B will remove brush, asphalt, rough grade, seed, straw (alt bid)
- C-B will haul all debris off site and properly dispose in a legal landfill or recycling facility
- C-B will retain all salvage rights as of date quoted
- C-B is a "Class A" Indianapolis Wrecking Contractor
- C-B insurance coverage includes: 2MM general aggregate GL, 1MM auto liability, 1MM workers compensation, and 5MM excess liability

Exclusions, Clarifications, & Notes:

- Pre-demolition asbestos inspection – previously completed
- Removal of hazardous materials / asbestos (by owner)
- All stone / gravel / granular material to remain on site
- Import topsoil
- Wells
- Septic tank pumping or removal
- Removal or disposal of below ground storage tanks, tires, fuel oil tanks, oils, or liquids
- Removal or disposal of any trash, debris, concrete, etc. from previous structures not visible from the surface – unforeseen condition
- Concrete under asphalt
- Underground or overhead utility relocation or removal
- Site clearing or grade work other than described above
- Private utility locates (other than Indiana Underground #811)
- Note: It is the owner's responsibility to have final readings done on all utility if services are still active – C-B can't shut down active services
- Public utility disconnects / make safes – C-B will assist with calls, emails, and letters to utility companies
- Private utility disconnects / make safes
- Retainage
- Additional work directed and authorized after the start of the project will be charged at C-B's current T&M equipment and labor rates. All material, dump fees, rented tools, rented equipment, subcontractors, etc. will be at cost + 15% for coordination, overhead, and profit.
