Bond Hearing - Notice is hereby given to taxpayers of the Park District and other interested parties that the Board, immediately following the above hearing, will conduct a public hearing on the proposed issuance of special taxing district bonds of the Park District in the aggregate principal amount not to exceed \$1,250,000 (the "Bonds") for the purpose of (i) financing the costs of the Project, (ii) paying capitalized interest, if necessary, and (iii) paying costs of issuance of the Bonds. At said public hearing, all persons shall have the right to appear and be heard on the proposed issuance of the Bonds.
