PETITIONER:	The Ridge Group		
PETITION:	Kensington Gardens Secondary Plat		
REQUEST:	Petitioner requests approval of a Secondary for one (1) lot for a multi-family residential development. The subject property is approximately 8.5 acres.		
LOCATION:	The subject property is located along the eastside of Kensington Way, south of Wellington Way.		
ZONING:	The current zoning is Gateway Crossing PUD, which allows multi-family, single-family, and commercial land uses. However, the Real Estate encompassed by this Plat only allows multi-family residential land uses. The zoning and land use for the surrounding area are as noted below:

STAFF REVIEW: This property was rezoned to the Gateway Crossing PUD in 2001, and has allowed multifamily residential on the subject parcel since its inception. This property was primary platted sometime in the 2000s. The Plan Commission approved a Development Plan, to make way for a multi-family residential project, on this Real Estate last month.

The proposed lot has direct access to Kensington Way, and proper access to public utilities. The applicable setbacks, for the project have been provided, in accordance with the requirements of the PUD, and the BZA's conditions of approval.


This Plat has been to TAC and has satisfied all TAC comments.
