

ORDINANCE NO. 111224

AN ORDINANCE AMENDING ORDINANCE NO. 110922A

WHEREAS, the Town of McCordsville (the “Town”) is a political subdivision existing under the provisions of Ind. Code § 36-5-1, *et. seq.*;

WHEREAS, the McCordsville Town Council (the “Council”) is the fiscal body of the Town and is responsible for the adoption of and amendments to all ordinances;

WHEREAS, in December 2022, the Council adopted Ordinance No. 110922A, which established a monthly trash collection fee of \$13.98 per month;

WHEREAS, the Council engaged the services of Baker Tilly to conduct a rate study for trash collection service, a copy of which is attached hereto and incorporated by reference herein as Exhibit A;

WHEREAS, the Council has caused notice of a public hearing on the matter of amending the provisions of Ordinance No. 110922A to be published in accordance with Indiana Code 5-3-1, has conducted said public hearing on December 10, 2024, and has considered the evidence presented at said public hearing prior to the adoption of this Ordinance; and

WHEREAS, the Council believes the amendment of Ordinance No. 110922A as to the monthly charge for trash collection services is in the best interest of the health, welfare, and maintenance of the citizens of McCordsville, Indiana and the efficient operation and management of the trash collection utility.

THEREFORE, BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

Section I: Ordinance No. 110922A is hereby deleted in its entirety and inserted in lieu thereof shall be the following:

For the service provided by the Town of McCordsville, Indiana, consisting of the collection of trash, garbage, refuse, and recycling services (i.e. the “Trash Collection Service”), there shall be charged to and collected from the owners of each and every lot, parcel of real estate, or building that receives said Trash Collection Service a fee of \$18.48 per month (the “Trash Collection Fee”).

Section II: All other provisions of Ordinance No. 110922A not heretofore amended, nor amended by this ordinance, shall remain in full force and effect.

Section III: This Ordinance shall be in full force and effect from and after January 1, 2025.
