**AN AMENDED ORDINANCE SETTING THE TOWN OF MCCORDSVILLE,  
INDIANA’S SCHEDULE OF PENALTIES AND AMENDING THE  
MCCORDSVILLE, INDIANA CODE OF ORDINANCES**

WHEREAS, the Town of McCordsville (the “Town”) is a municipality organized and existing under the provisions of Ind. Code 36-5-1;

WHEREAS, the Council President (the “Executive”) is the Executive of the Town;

WHEREAS, the McCordsville Town Council (the “Council”) is the fiscal body of the Town;

WHEREAS, the Town of McCordsville (“Town”) maintains fines for various ordinance violations established by the Town of McCordsville under Chapter 32.04 of the McCordsville Code of Ordinances;

WHEREAS, the Town has reviewed the existing Schedule of Penalties and has determined that amendments are needed; and

WHEREAS, the Council deems it appropriate at this time to revise and amend the Schedule of Penalties to be in effect beginning January 20, 2025; and

WHEREAS, Exhibit A, attached hereto and incorporated herein, represents the 2025 Town of McCordsville Schedule of Penalties.

NOW, THEREFORE, be it ordained by the Town Council of the Town of McCordsville, Indiana:

Section 1: The 2025 Town of McCordsville Schedule of Penalties, attached hereto as Exhibit A and incorporated herein, is hereby adopted.

Section 2: Any existing Ordinances, or portions thereof, conflicting with the fines identified in Exhibit A are hereby repealed.

Section 3: Any fines not specifically identified in Exhibit A, including but not limited to any related to stormwater, sewer, and/or impact fees, shall remain in effect.

Section 4: Section 10.99 of the McCordsville Code of Ordinances shall also remain in effect.

Section 5: The attached 2025 Town of McCordsville Schedule of Penalties may be amended throughout the year, as determined to be appropriate by the Town, to reflect any changes in the fines referenced therein or to include additional fines currently not listed in the Schedule of Penalties.

Section 6: This Ordinance shall be in full force and effect beginning January 20, 2025.
