- Parks Board: Did not meet.
- Redevelopment Commission: They had discussions about the acquisition of several properties and contracts with Bondry and Bose McKinney.
- Vernon Township Fire Committee:
  - Vernon Township VTFD Year in Review was presented by Florence May, the Vernon Township Trustee, and she elaborated on what is provided by the Township. Mr. Brewer explained how important it is to celebrate the 5-year anniversary of the Vernon Township Fire Protection Territory. Chief Elder presented the 2024 annual report for the Vernon Township Fire Department and elaborated on the history of the Fire Department with their personnel and training, as well as statistical information.
