**RESOLUTION NO. 061025**

**A RESOLUTION DECLARING CERTAIN PERSONAL PROPERTY  
TO BE SURPLUS**

WHEREAS, it has come to the attention of the Town Council of the Town of McCordsville, Indiana ("Town") that certain property owned by the Town is now surplus and should be disposed of;

WHEREAS, Ind. Code § 5-22-22 *et seq.* authorizes the Town to follow certain procedures to dispose of surplus property;

WHEREAS, I.C. § 5-22-22-10 specifically allows the Town to "exchange property with another governmental body upon terms and conditions agreed upon by the governmental bodies as evidenced by adoption of a substantially identical resolution by each entity."

WHEREAS, the McCordsville Police Department no longer needs the property identified on Exhibit A and the Milan Police Department has a need for the property identified on Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MCCORDSVILLE, INDIANA AS FOLLOWS:

Section 1. The above recitals are incorporated by reference.

Section 2. The personal property identified in Exhibit A, which includes six radios, a public safety mic, a radio antenna, a radio battery charger and charger cord, batteries, and plastic belt holders, belongs to the Town, is no longer needed, and is declared surplus property.

Section 3. The McCordsville Police Department and the Milan Police Department have agreed upon the price of \$6,000.00 for the property in Exhibit A.

Section 4. The McCordsville Town Council approves the transfer of property identified in Exhibit A for the agreed upon price.

Section 5. Upon the approval of a substantially similar resolution and payment to McCordsville of the agreed upon price by the Milan Town Council, the McCordsville Police Department agrees to help facilitate the transfer of the property.

Section 6. This Resolution is effective upon passage.
