
Explain the reason(s) why the applicant has proposed this annexation:



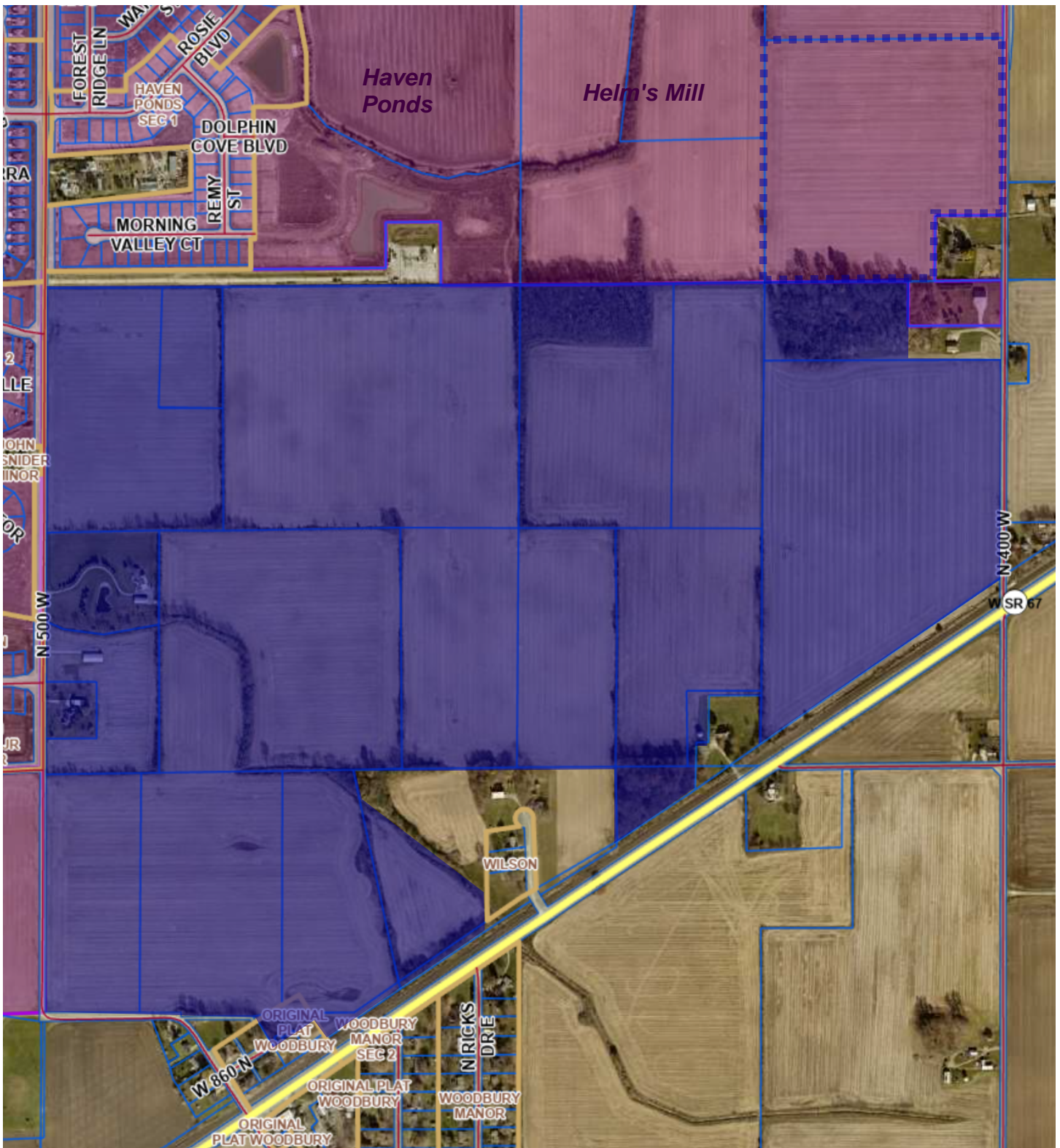
