Public notice is given that the McCordsville Town Council will, on the 9th day of September, 2025, at 6:00 p.m., at the McCordsville Town Hall, located at 6280 Vail Road, McCordsville, IN 46055, introduce and hold a public hearing on Ordinance 081225E, titled An Ordinance Imposing a Municipal Wheel Tax and Motor Vehicle License Excise Tax and Creating The Town of McCordsville Wheel Tax Fund and the Town of McCordsville Motor Vehicle License Excise Surtax Fund. The ordinance authorizes Council to adopt a local wheel tax and excise tax and create non-reverting funds for the collection of each tax. The proposed effective date is January 1, 2027.

Public notice is hereby given that at said public hearing, the McCordsville Town Council, as the designating body, will receive and hear all remonstrances and objections from interested persons. Copies of the proposed ordinances are on file with the McCordsville Clerk-Treasurer. Any oral comments concerning the ordinance will be heard. The hearing may be continued from time to time as may be found necessary.
