ORDINANCE NO. 050818

ORDINANCE AMENDING ORDINANCE NO. 021318

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has previously adopted Ordinance No. 021318, which in part established a Board of Metropolitan Police Commissioners consisting of three (3) members; and

WHEREAS, Indiana Code § 36-8-9-3.1(a) provides that such a board may consist of either three (3) members or five (5) members; and

WHEREAS, as contained within Ordinance No. 021318, Section I, enacting Title III, Chapter 35, § 35.06(B)(1) and (C) initially created a Board of Metropolitan Police Commissioners consisting of three (3) members and specified their terms of office; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, upon further consideration, believes it is in the best interest of the efficient operation and management of the Board of Metropolitan Police Commissioners that the membership of said board be increased to five (5) members.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Title III, Chapter 35, § 35.06(B) as heretofore created by Ordinance No. 021318 is hereby deleted in its entirety and inserted in lieu thereof is the following:

(B) Board Membership.

(1) The Board of Metropolitan Police Commissioners shall consist of five (5) members appointed by the Town Council. The members must be of good moral character, have no felony convictions for criminal acts, and legal residents of the Town of McCordsville. Not more than two (2) members may be of the same political party, if

individuals who satisfy this requirement can be found to serve on the Board with reasonable and diligent efforts. Members of the Town's Police Department may not be appointed to serve on the Board. A member of the Town Council may be appointed to serve on the Board as an ex officio member, subject to the provisions set forth herein.

(2) The Town Council may appoint one (1) Town Council member to serve as an ex officio member, who must vacate their membership upon the end of the Council member's term or vacating of office. Said ex officio member may not receive compensation for their service, nor are they required to post a bond.

SECTION II

Title III, Chapter 35, § 35.06(C) as heretofore created by Ordinance No. 021318 is hereby deleted in its entirety and inserted in lieu thereof is the following:

(C) Term. The Board members' terms shall be three (3) years, expiring on January 1 of the third year after the member's appointment. However, to establish staggered terms, two (2) initial members shall be appointed for a one-year term, two (2) initial members shall be appointed for a two-year term, and one (1) initial member shall be appointed for a three-year term. Each member serves at the pleasure of the Town Council and may be removed for any cause that the Town Council considers sufficient.

SECTION III

This Ordinance shall be in full force and effect from and after its passage.

SECTION IV

Introduced and filed on the 8th day of May, 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 5 in favor and 0 opposed pursuant to I.C. 36-5-2-9.8.
