ORDINANCE AMENDING TITLE VII, CHAPTER 72, SCHEDULE II

WHEREAS, upon the recommendation of the Public Works Committee, the Town Council of the Town of McCordsville, Indiana, has been advised of the need to amend Title VII, Chapter 72, Schedule II to add to the schedule of intersections; stop signs, regulations regarding the intersection of Woodhaven Drive and Woodhammer Trail; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, believes the creation of a 4-way stop at the intersection of Woodhaven Drive, Woodhammer Trail and N. Woods Edge Drive is in the best interest of the citizens of McCordsville, Indiana.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Title VII, Chapter 72, Schedule II, is hereby amended by the addition of the following:
