ORDINANCE AMENDING TITLE VII, CHAPTER 72, SCHEDULE I

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore created a school zone on County Road 900 North associated with the Montessori School; and

WHEREAS, as of January, 2020, said Montessori School has relocated its facilities at the intersection of County Road 900 North and County Road 600 West thereby eliminating the need for the previously existing school speed zone; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, believes that the school zone as currently stated within Title VII, Chapter 72, Schedule I, is no longer in the best interest of the health, safety, and welfare of the citizens of McCordsville, Indiana, and should be eliminated.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

SECTION I

Title VII, Chapter 72, Schedule I, shall be amended by deletion of the following language:

School Zone – County Road 900 North – Montessori School	Easterly and westerly	Monday through Friday, on days the school is in session, between the hours of 7:30 a.m. and 4:30 p.m., no vehicle traveling in an easterly or westerly direction on County Road 900 North from 1,584 feet from its intersection County Road 700 West to a point 2,640 feet east of said intersection	30 mph

SECTION II

This Ordinance shall be in full force and effect, from and after its passage, due publication and posting as required by law within the Town of McCordsville, Indiana.
