Variance Request for Fence Panels

- Motion by Mr. Brewer to recess Town Council meeting and open Drainage Board. Strayer.
 - Brandy Stepan made the presentation. They would like to put three sets of two 6' x 8' panels in the drainage easement on top of the mound behind their home.
 - Motion by Mr. Strayer to approve the variance for the panels subject to two conditions



1. The petitioners enter into an encroachment agreement with the Town
 2. Any trees within the drainage easement are removed. Brewer. 5-0
- Motion by Mr. Longman to reconvene Town Council meeting and close the Drainage Board. Williams.

Mt. Comfort Corridor Land Use Strategy Update

- Jim Rawlinson with Veridus Group stated the working with Coalition for Smart Growth. Three years ago, the ULI Study was done. Stantec and Thomas P Miller working on a Land Use Plan and a Housing Plan. Applied Economics working on an Economic Impact Analysis.
- Working closing with the Towns for a final plan to be delivered in July or August.
- The Mt. Comfort Corridor is divided into 6 zones. McCordsville is Zone 1 and 2. Housing Study found the current stock only meets 67% of demand. Presented maps with proposed land use.

McCord Square Informal Presentation

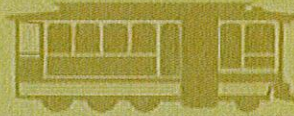
- Shelby Bowen, President of Rebar, stated Rebar would like to partner with the Town. Drew Kelly and Jerry Ewing are partners. Working with the Veridus Group.
- The developer presented conceptual plans which includes commercial, residential, mixed use, and green spaces for the community.
- Mr. Bowen stated Rebar would further refine the plans and present an economic development agreement with the terms.

The Colonnade Informal Development Presentation

- Briane House, an attorney with Pritzke and Davis represented the developers Platinum Properties. Paul Rioux with Platinum Properties stated he worked on 15,000 homes and asked if the children were able to walk to school. They would work to connect trails if kids were allowed to walk. Todd Pyatt with Finecraft Builders also available for questions. Beazer Homes would be a proposed builder along with Finecraft Homes.
- North of 700 N and South of 750 N, east of the elementary school. Single family homes.
- 46 attached units, 40 detached with smaller lots, 70 detached units on lots 60' by 130' feet and 90 detached units on 80' by 140' lots.
- 246 homes with great architectural details, considered contemporary classic
- Over 7.5 acres for a common area with a water feature and a bridge connecting the north and south parts of the development.

Al Neyer Annexation

- Briane House, with Pritzke and Davis, represented Al Neyer Co.'s petition for annexation.
- Alexis Sowder from KSM Location Advisors answered questions and helped with presentation.
- The speculative building would over 1 million square feet. \$60.2 million investment.
- Developer asked for an alternative tax abatement schedule and set back variance reductions.

Policy Analytics Interim Progress Report

- Ryan Crum stated the Fiscal Sustainability had been in the works for about 6 months. The land use will be combined with the financials and expenditures and produce different scenarios to analyze the capital investments and the cost of municipal services necessary. It should wrap up in September and be presented to Council after.

Mr. Crum asked Council if we had a partner or if we should pursue the grant. Council advised not to pursue the grant; we do not have a partner.

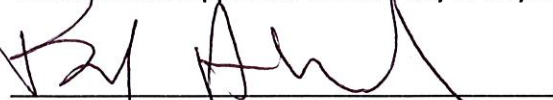
