#### **Approval of Meeting Minutes**

#### **Old Business**

##### **Park Director Status**

### **Removing StoryWalk at Old School Park during construction**

Ms. Jones stated that StoryWalk will be in the way during construction so the signs will need to be removed and that their current condition was deteriorating. The signs will need to be stored during the construction and hopefully StoryWalk can be reestablished at the park or moved to the proposed park by the new NineStar building next to McCord Square.

Ms. Bennett from the Vernon Township Public Library discussed future ideas on how to improve StoryWalk by making it more interactive and accessible using Enviro-signs.

### **Old School Park Playground Equipment Recommendations**

Mr. Gropp explained the different phases of construction at Old School Park and showcased options for new playground equipment, restroom facilities and a new shelter for phase 1. The board discussed the different options available and rearranging placement of each of the amenities.

### **Youth Sports Park Study**

Mr. Gropp asked for board discussion regarding preliminary planning for the future of a youth sports park that would feature baseball diamonds and multi-use fields for football, soccer, and other sports to fulfill the community's needs.

Mr. Gropp stated that several analyses would need to be conducted and meetings held with the school district and community stakeholders.
