The McCordsville Plan Commission (PC) meets monthly at 7:00 pm on the date listed below. The Plan Commission reviews all primary plats, rezones, PUD amendments, and non-single-family residential Development Plans/Secondary Plats. All petitions shall be filed in the Town's online permit system by the applicable filing date.

**Please note that all petitions (unless otherwise directed by staff) will need to go before the Technical Advisory Committee (TAC)<sup>1</sup> prior to Plan Commission, and shall file revised plans addressing TAC comments by the TAC Revisions deadline below. If additional revisions are needed, they must be received no later than the Final Revisions Deadline.**
