RESOLUTION NO. 102125

A RESOLUTION OF THE TOWN OF MCCORDSVILLE, INDIANA AUTHORIZING THE DISPOSAL OF EXCESS PERSONAL PROPERTY

WHEREAS, the Town of McCordsville, Indiana, owns certain personal property that is no longer needed, is obsolete, or unfit for the purpose for which it was acquired; and

WHEREAS, Indiana Code § 5-22-22 and Indiana Code § 36-1-11 authorize a political subdivision to dispose of personal property that is no longer needed or has no value; and

WHEREAS, the Town has identified certain items of personal property that meet these criteria and recommends they be declared surplus and properly disposed of;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of McCordsville, Indiana, as follows:

Section 1. Declaration of Surplus Property

The Town Council hereby declares the personal property listed in **Exhibit A** as surplus or excess personal property that is no longer needed by the Town of McCordsville.

Section 2. Authorization to Dispose

The Town Manager, Clerk-Treasurer, or their designee is authorized and directed to dispose of the property in accordance with Indiana Code § 5-22-22 and Indiana Code § 36-1-11. Such disposal may include sale, donation, trade-in, transfer to another governmental entity, or disposal as waste if deemed to have no remaining value.

Section 3. Method of Disposal

The method of disposal shall be chosen based on the nature and estimated value of each item and may include:

- Public auction or sealed bids;

- Internet sale via authorized platforms;
- Donation to nonprofit organizations;
- Transfer to another unit of government;
- Recycling or discard if the item is not marketable.

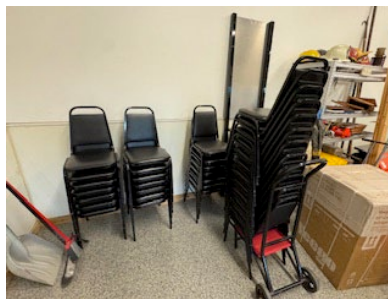

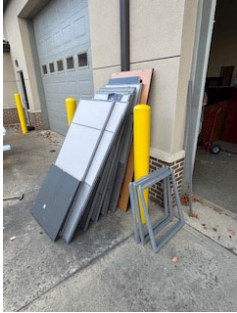

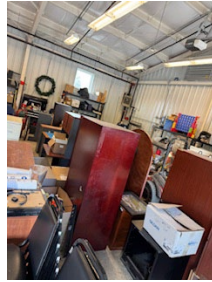
