ORDINANCE NO. 121410A

ORDINANCE ADOPTING THE McCORDSVILLE SUBDIVISION CONTROL ORDINANCE

WHEREAS, for approximately 12 months, a group of citizens denominated as The 2011 Steering Committee, in conjunction with various Town employees, the Town Engineer, the Town Manager, consultants from HNTB, and the Town Attorney, have researched and studied the McCordsville Comprehensive Plan, and the provisions of the proposed McCordsville Zoning Code, as well as the provisions of Subdivision Control Ordinances from other jurisdictions, resulting in the proposed McCordsville Subdivision Control; and

WHEREAS, said Plan has been reviewed by the McCordsville Plan Commission who, pursuant to statute, conducted a public hearing regarding the contents of the proposed Subdivision Control Ordinance on November 30, 2010, after which, by motion made, seconded, and duly passed, the McCordsville Plan Commission has recommended the adoption of Exhibit A attached hereto and incorporated by reference herein as the McCordsville Subdivision Control Ordinance, which recommendation has been formally certified to the Town Council of the Town of McCordsville, Indiana; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, believes the adoption of the recommended McCordsville Subdivision Control Ordinance to be in the best interest of the health, safety, and welfare of the citizens of McCordsville, Indiana.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

SECTION I

Exhibit A, attached hereto and incorporated by reference herein, is hereby adopted as the McCordsville Subdivision Control Ordinance, pursuant to Indiana Code 36-7-4-701 et seq.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, due publication, the filing of a certified copy of this ordinance being filed with the Hancock County Recorder, but in no event earlier than January 1, 2011.

SECTION III

Introduced and filed on the $\underline{14^{\text{M}}}$ day of $\underline{December}$, 2010. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of $\underline{5}$ in favor and $\underline{0}$ opposed pursuant to I.C. 36-5-2-9.8.
