5. Old Business

A. Chief's Job Posting – It was posted on June 14, 2019 which was last Friday. The position is going to be open for 2 Weeks. It was posted on the Town of McCordsville and ILEA website. Mr. Mark Walker has been receiving the applications and has been sending follow up letters to let the applicants know he has received their application. Mr. Claude Robinson and Mr. William Benson have volunteered to review the applications.

- B. Update on Mr. Harold Rodgers Agreement
- 1. At the last meeting we accepted the Memoranda of Understanding presented by Mr. Harold Rodgers's Attorney with an amendment regarding Mr. Harold Rodgers retiring in good standings, retirement badge, and credentials. The amendment was not received well nor accepted. Mr. Gregg Morelock our Legal Council has a compromise of the badge that will say Retired in large bold print. The badge would not allow him to legally use it as an active Sworn Police Officer. The concern about certifying the right to retain a weapon. The ILEA will do the certification, not the Town of McCordsville, so Mr. Harold Rodgers will have to go to ILEA to get

certified to retain his weapon. Mr. Harold Rodgers's ability to have a weapon has been resolved with the State of Indiana. Motion needed to approve originally Memoranda of Understanding. 1^{st} Mr. William Benson 2^{nd} Mr. Claude Robinson – Motion Carried 5-0

2. Discussion of salary for Mr. Harold Rodgers. According to the agreement, he should be paid the full amount. So, in this case his pay would increase from June 01, 2019 to August 01, 2019 with longevity.

McCordsville Town Council Board needs to know have important this is for Public Safety for this area. Currently the closes Repeaters are City of Lawrence and Indiana State Police Post at Pendleton.
