ORDINANCE NO.

ORDINANCE AMENDING TITLE IX, CHAPTER 93, § 93.02, §93.03, and §93.04(A)(1) OF THE CODE OF ORDINANCES OF THE TOWN OF McCORDSVILLE, INDIANA

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore adopted Ordinance No. 111318 establishing noise levels that are acceptable within certain districts and during certain time periods; and

WHEREAS, upon the recommendation of staff members for the Town Council of the Town of McCordsville, Indiana, the Town Council believes that it is in the best interest of the health, safety, and welfare of the citizens of McCordsville, Indiana, that said revisions be further amended.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Title IX, Chapter 93, § 93.04(A)(1) shall be amended by the addition of the following language located immediately following provision (1)(f):

"Notwithstanding the provisions set forth above, the sound level limits shall be 74 dB(A) during the hours of 7:00 a.m. to 10:00 p.m. and 64 dB(A) during the hours of 10:00 p.m. to 7:00 a.m. where the source property is zoned commercial and when said commercially zoned property was developed prior to the effective date of this Ordinance and the complainant's property was developed after the effective date of this Ordinance."

SECTION II

Title IX, Chapter 93, §93.02 shall be amended by deleting the definition for commercial and replacing with the definition in lieu thereof the following:

A. *Commercial area* shall mean any parcel of land zoned P, CN, CO, CR, PUD-M, PUD-C, TC, and OT under the Zoning Ordinance.

SECTION III

Ordinance Number 111318, SECTION 1 is hereby amended to correct a scrivener's error to reference §93.03 to §93.02.

SECTION IV

This Ordinance shall be in full force and effect from and after its passage and due publication.
