- 2. How do these plans impact the site master plan? Please provide a revised master plan.
- 3. Is there plans for pedestrian access to eastern half of the site? A vehicular drive is show with no width for any future path/sidewalk.
- 4. Please show riprap on the end section entering the pond near structure #2 per town standards.
- 5. Silt fence should be extended along the north area of the construction limits near the limits of the proposed 861 contour.
- 6. Stormwater report references that Hancock County's stormwater manual was used for the required detention calculations and other references. Please review and revised if needed to use McCordsville's Stormwater Technical Standards Manual.
- 7. I did not find any inlet spacing calculations (curb turnouts) in the stormwater report. Please make sure that is included to Kerry Daily at Burke.
