Hampton Walk Home Product Line-up

Mr. Crum explained the purpose of the meeting, stating that it is to involve the Committee in the rezone process to provide recommendations to the Plan Commission. The board discussed three different ways the recommendations could be made (see Staff Report appended to these minutes).

The members discussed:

- masonry requirements on homes with architectural styles that do not look good with brick or stone and brick wrap around the entire home, at least as a wainscot, for other models.
- Impact lot map and the supplementary architectural requirements for those lots
- The three options of presenting decisions to the Plan Commission. The Committee members chose option 2.

Elevation Review

Townhomes

The members discussed the three options presented for the Townhome style and the landscaping plans for the townhomes. The members decided to recommend that the maximum unit count row be no more than seven units and to let the Plan Commission decide the style appropriate to the roadway the townhomes front.

Masterpiece area

The Committee recommends that home elevations that have wainscot on the front also wrap all around the house.

The Committee did not have any objections to home styles or elevations.

- Wyatt Coastal Cottage (without masonry)
- Wyatt Modern Farmhouse (without masonry)
- Avery Urban Modern (The ARC notes that they had a mixed reaction on this elevation)

The Committee recommends that home elevations that have wainscot on the front also wrap all around the house.

Patio Homes series

The Committee did not object to the models and elevations in this product series. They asked for a brick wainscot wrap on the homes and that lots along the pond be designated as impact lots.

Paired Homes series

The Committee wants to see an offset between the two garages. They also asked for masonry on the garage returns.

Maple Street series
