## **MEMORANDUM OF UNDERSTANDING**

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2023, by and between the Town of McCordsville, Indiana, the Hancock County Commissioners, the Hancock County Council and the Hancock County Redevelopment Commission.

WHEREAS, the Town of McCordsville, Indiana, the Hancock County Commissioners, the Hancock County Council and the Hancock County Redevelopment Commission are consistently involved in potential and/or realized economic development projects within Western Hancock County; and

WHEREAS, the Town limits of McCordsville, Indiana extend to the south edge of the right of way of County Road 500 North as depicted on Exhibit A, attached hereto and incorporated herein with the rest of the property bordering County Road 500 North remaining under the jurisdiction of Hancock County and its various governmental entities; and

WHEREAS, in the spirit of cooperation, the parties wish to enter into this Memorandum of Understanding to memorialize the process to be utilized to further such cooperation, when inquiries are made regarding possible and/or pending developments along County Road 500 North.

BE IT THEREFORE AGREED BY THE PARTIES AS FOLLOWS:

1. Whenever the Town of McCordsville, Indiana or any member of its staff receives a request for information or any contact regarding an economic development project outside the incorporated limits of McCordsville, Indiana, the Town Manager or the McCordsville Plan Commission Director who will direct such inquiries to the other parties by electronic mail advising them of the nature and content of such communication, as well as the source and contact information of the person or entity making such inquiries.

2. Whenever the Hancock County Commissioners, the Hancock County Council and/or the Hancock County Redevelopment Commission receive a request for information or any communication regarding a potential economic development project along the north side of County Road 500 North within the McCordsville incorporated limits, the party receiving such communication shall notify the person or entity to contact the McCordsville Town Manager for further information and provide to the Town of McCordsville, Indiana the source and contact information of the person or entity making such inquiries.


