

**ORDINANCE NO. 021423B**

**ORDINANCE TO AMEND TITLE IX, CHAPTER 90 OF THE  
McCORDSVILLE CODE OF ORDINANCES**

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana has previously adopted Ordinance No. 121206C enacting certain provisions regarding animals which provisions are located within Title IX, Chapter 90 of the McCordsville Code of Ordinances; and

**WHEREAS**, since the adoption of said Ordinance, Hancock County, Indiana, and the City of Greenfield, Indiana, have entered into an Interlocal Agreement by which the Greenfield Animal Management Department, or whatever entity is providing animal control services within McCordsville, Indiana at the time services are needed; and

**WHEREAS**, it has been recommended to the McCordsville Town Council by staff that Title IX, Chapter 90, § 90.99 be amended to reflect that enforcement of the provisions contained therein, with the exception of actions required by law to be taken by the McCordsville Police Department, shall be the responsibility of the Greenfield Animal Management Department or whatever entity is providing animal control services within McCordsville, Indiana at the time services are needed.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana that:

**SECTION I**

Title IX, Chapter 90, § 90.99 shall be amended to be entitled PENALTY AND ENFORCEMENT and shall be further amended to add subdivision (L) to read as follows:

It is hereby acknowledged and expressly stated that should any member of the Town of McCordsville staff, except Town of McCordsville Police Department, become aware of any possible violation of the provisions of this chapter or have concerns regarding the welfare of any animal, their sole duty and responsibility is to make a report to the Greenfield Animal Management Department, or whatever entity is providing animal control services within McCordsville, Indiana at the time services are needed, to take whatever enforcement action said department deems necessary.

**SECTION II**

This Ordinance shall be in full force and effect from and after its passage and due publication according to law.

**SECTION III**






