

## **ORDINANCE NO. 121223C**

### **ORDINANCE TO AMEND ORDINANCE NO. 080922 AND ORDINANCE NO. 021423A**

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana has previously adopted Ordinance No. 080922 and Ordinance No. 021423A, Ordinances to Appropriate Sums from the ARPA Coronavirus Local Fiscal Recovery Fund for Purposes that Fulfill the Intent of the American Rescue Plan Act in Aid of the Town of McCordsville's Recovery From the Effects of the COVID-19 Emergency; and

**WHEREAS**, Ordinance No. 080922 authorizes the Town Council to amend said ordinance when the Town Council approves additional appropriations from the ARPA funds for the benefit of the community; and

**WHEREAS**, by the recommendations of staff, the Town Council of the Town of McCordsville, Indiana now believes that Ordinance No. 080922 and Ordinance No. 021423A should be amended as set forth below appropriating funds for calendar year 2024.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana that:
