#### **ORDINANCE AMENDING TITLE VII, CHAPTER 72, SCHEDULE II**

WHEREAS, upon the recommendation of the Public Works Committee, the Town Council of the Town of McCordsville, Indiana, has been advised of the need to amend Title VII, Chapter 72, Schedule II to add to the schedule of intersections; stop signs, regulations regarding West May Apple Drive at its intersection with West Silverthorne Drive and West Windsor Drive at its intersection with Chelmsford Drive and with Stubbington Lane; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, believes the creation of a 4-way stop at the intersection of West May Apple Drive at its intersection with West Silverthorne Drive and West Windsor Drive at its intersection with Chelmsford Drive and with Stubbington Lane is in the best interest of the citizens of McCordsville, Indiana.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana, as follows:

## SECTION I

Title VII, Chapter 72, Schedule II, is hereby amended by the addition of the following:

Direction(s)	Street/Road	Intersection
Eastbound and westbound	W. May Apple	At its intersection with Silverthorne Dr.
Westbound	W. Windstor Dr.	At its intersection with Chelmsford Dr. and Stubbington Ln.
