ORDINANCE NO. 031318

ORDINANCE AMENDING TITLE XI, CHAPTER 110, § 110.02

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has previously enacted an ordinance codified in Title XI, Chapter 110, regarding the licensure of peddlers and itinerant merchants within McCordsville, Indiana; and

WHEREAS, contained within said provisions is § 110.02 entitled Exceptions; and

WHEREAS, it has been brought to the attention of the Town Council of the Town of McCordsville, Indiana, by staff, that certain amendments to § 110.02 would be in the best interest of the welfare and of benefit to the citizens of McCordsville, Indiana.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Title XI, Chapter 110, § 110.02, shall be amended by adding the following:

(C) Any nonprofit organization, recognized by the McCordsville Town Manager as such, utilizing exclusively minors under the age of 17 to perform the duties of a peddler or solicitor as defined herein shall be exempt from those portions of the Application for Certificate of Registration contained in § 110.04 below as deemed appropriate by the Town Manager.

SECTION II

This Ordinance shall be in full force and effect from and after its passage.

SECTION V

Introduced and filed on the 13th day of March, 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of <u>5</u> in favor and <u>9</u> opposed pursuant to I.C. 36-5-2-9.8.
