

AV Overview

Sensory Technologies is to provide audio/visual design, equipment, and services, specific to the rooms listed below and further detailed in the following scope of work (SOW).

- Town Hall (City Council Chamber Area)
- Town Hall (Administration Conference Room)

Town Hall (City Council Chamber Area)

This room will receive a complete renovation of its presentation system, that will include (3) new displays for viewing of content/ presentations, new digital cabling and digital (HDMI) inputs, and new control & switching infrastructure that will replace the existing analog and RF signal system that is fully depreciated and obsolete.

This space will be used daily for larger team and department meetings, public gatherings, rented/reserved events, and formal city governance / meetings. The space will be designed to offer basic presentation (i.e. PowerPoint, shared documents, laptop sharing, and a dedicated Room PC), and shared wireless collaboration (i.e. wireless presentation)

**OFE refers to OWNER PROVIDED EQUIPMENT

Display & Sources

This proposal is calling for (3) total displays, which will provide both audience viewing, council viewing, and presenter viewing in the City Council space. Each of these displays will provide the same, simultaneous distributed video feed from the source that is selected at the control panel.

- (2) 75" Commercial grade, LED displays will be mounted at the front of the house, 1 at the corner wall behind the council desk, and the other on the wall behind the lectern. Each will be wall mounted
- (1) 75" Commercial grade, LED display will be wall mounted on the right hand wall in the overflow area (Community Room)

Audio

The room has an existing audio switchboard that controls the existing council microphones, lectern microphone, and (2) wireless lavalier microphones. This will remain as is, and ONLY CONTROL THOSE THREE SOURCES.



Sensory will provide and integrate a new amplifier and (6) new ceiling speakers that tie directly into the Digital Presentation System. In the future, as the audio / microphones are replaced, this will allow space to tie into.

Company shall not deactivate the software license without first issuing adequate notice to Client and providing adequate opportunity to remit payment in full. Should system deactivation occur, the touch panel screen controlling the Equipment shall display notice of payment past due.
