

## LAND DESCRIPTION


Part of Block "A" in Deer Crossing Block "A" Record Plat, the plat of which is recorded in Plat Cabinet C, Slide 25, Instrument Number 2009063 in the Office of the Recorder of Hancock County, Indiana, and also part of the Northwest Quarter of Section 23, Township 17 North, Range 5 East of the Second Principal Meridian, all in Vernon Township, Hancock County, Indiana, more particularly described as

COMMENCING at the northwest corner of said Northwest Quarter, said point being marked by a Harrison monument; thence South 00 degrees 06 minutes 06 seconds West (grid bearing based upon Indiana State Plane — East Zone (NAD83, 2011, EPOCH 2010.0000) along the west line of said Northwest Quarter a distance of 1149.86 feet to the northwest corner of a 7.00-acre tract of land described in Instrument Number 040009601 in said Recorder's Office, said corner being the POINT OF BEGINNING: thence North 89 degrees 12 minutes 05 seconds East along the north line of said tract a distance of 1333.83 feet to the west line of said Deer Crossing Block "A" Record Plat; thence North 00 degrees 05 minutes 57 seconds East along the west line of said plat a distance of 390.65 feet; thence North 89 degrees 12 minutes 05 seconds East a distance of 573.65 feet to the east line of said plat; thence South 00 degrees 05 minutes 57 seconds West along said east line a distance of 759.44 feet to the southeast corner of said plat; thence South 89 degrees 12 minutes 05 seconds West along the south line of said plat a distance of 573.65 feet to the southwest corner thereof, being also a northwest corner of Deer Crossing, Section Five, the plat of which is recorded in Plat Cabinet C, Slide 256, Instrument Number 070007012 in said Recorder's Office; thence South 00 degrees 05 minutes 57 seconds West along a west line of said Deer Crossing, Section Five a distance of 120.99 feet; thence South 89 degrees 12 minutes 05 seconds West along a north line of said Deer Crossing, Section Five and the north line of Deer Crossing, Section Four, the plat of which is recorded in Plat Cabinet C, Slide 190, Instrument Number 050000802 in said Recorder's Office a distance of 1333.85 feet to said west line of said Northwest Quarter; thence North 00 degrees 06 minutes 06 seconds East along said west line a distance of 489.79 feet to the POINT OF BEGINNING, containing 24.996 acres, more or less.


#### PLANTING NOTES:

- 1. LANDSCAPING AS SHOWN SUBJECT TO UTILITIES, GRADING AND DRAINAGE IMPROVEMENTS AND EASEMENTS
- 2. ALL LANDSCAPING WITHIN THE ENTRANCE MEDIAN WILL BE MAINTAINED BY THE HOA.
- 3. PLANT LOCATION SHALL BE STAKED BY THE CONTRACTOR AND REVIEWED BY THE LANDSCAPE ARCHITECT BEFORE PLANTING OPERATIONS COMMENCE. ADJUST AS REQUESTED TO AVOID UTILITY CONFLICTS.
- 4. NOTE THAT PLANT LIST QUANTITIES ARE FOR THE CONTRACTOR'S CONVENIENCE ONLY. CONTRACTOR SHALL VERIFY ALL QUANTITIES PRIOR TO SUBMITTING THEIR BID FOR THIS PROJECT.
- S. ALL PLANT MATERIAL SHALL CONFORM TO ANSI Z60.1 STANDARDS. LANDSCAPE ARCHITECT PRESERVES THE RIGHT TO REJECT ANY PLANT MATERIAL NOT MEETING INDUSTRY STANDARDS.
- 6. STREET TREES ARE TO BE SPACED AT 40' O.C.,
- 7. PLANTING BEDS SHALL RECEIVE A 3" LAYER OF SHREDDED BARK MULCH.
- 8. SEED AND STRAW MULCH ALL LAWN AREAS DISTURBED DURING CONSTRUCTION, UNLESS NOTED OTHERWISE.
- 9. REMOVE ALL STAKING AS SOON AS THE TREE HAS GROWN SUFFICIENT ROOTS TO OVERCOME THE PROBLEM THAT REQUIRED THE TREE TO BE STAKED. STAKES SHALL BE REMOVED NO LATER THAN THE END OF THE FIRST FULL GROWING SEASON AFTER PLANTING. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO REMOVED STAKING MATERIALS.
- 10. EXCAVATION FOR TREE PITS SHALL BE 2.5 TIMES DIAMETER OF ROOT BALL, SET ON UNDISTURBED SUBBASE.
- 11. REMOVE ALL RIBBONS OR TREE TAGS AFTER APPROVAL BY LANDSCAPE ARCHITECT.
- 12. TREES SHALL BE ALIGNED AND PLUMB AFTER WATERING AND SETTLING.
- 13. PRUNE TREES AS REQUIRED, AND AS DIRECTED BY THE LANDSCAPE ARCHITECT.
- 14. STAKING AND GUYING TO BE AT THE DISCRETION OF THE CONTRACTOR. TREES SHALL NOT SWAY EXCESSIVELY.
- 15. TREE SHALL BE TURNED SO BEST SIDE FACES FRONT.
- 16. CONTRACTOR SHALL INSTALL TWO REINFORCED RUBBER HOSE SECTIONS WITH A DOUBLE STRAND OF #14 WIRE. WRAP WIRE A MINIMUM OF TWO TIMES AROUND EACH POST.
- 17. THE FIRST STAKE SHALL BE DIRECTLY SOUTHWEST OF THE TREE TRUNK.








3 MULTI-STEM TREE PLANTING




4 ENTRY MONUMENT CONCEPT NOT TO SCALE
