

ORDINANCE NO.

**ORDINANCE AMENDING TITLE III, CHAPTER 32, § 32.04
OF THE CODE OF ORDINANCES OF McCORDSVILLE, INDIANA**

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore adopted Ordinance No. 081412C, the same being a schedule of ordinance violations and fines for which that may be paid through McCordsville Ordinance Violations Bureau; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has determined that it is in the best interest of the administration of the Ordinance Violations Bureau that certain violations and penalties associated therewith should be removed from those which may be paid through the McCordsville Ordinance Violations Bureau.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana, as follows:

SECTION I

Title III, Chapter 32, § 32.04 shall be amended by deleting certain violations and fines associated therewith as follows:
