#### ORDINANCE NO. OGILIJA

# ORDINANCE REGULATING PARKING WITHIN THE TOWN OF McCORDSVILLE, INDIANA

**WHEREAS**, it has come to the attention of the Town Council of the Town of McCordsville, Indiana, that with increasing growth and traffic flow, the location, manner, and appropriate parking within the corporate limits of McCordsville, Indiana, is in need of revision; and

**WHEREAS**, upon recommendation of the Public Works Committee, the Town Council of the Town of McCordsville, Indiana, believes it is in the best interest of the health, safety, and general welfare of the citizens of McCordsville, Indiana, that parking be prohibited within a certain designated area on either side of County Road 700 North.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana, as follows:

#### **SECTION I**

It shall be unlawful for any person to park, stop, or leave standing an attended or unattended vehicle upon the paved portion of County Road 700 North and/or on or in the right-of-way on the north and south side of County Road 700 North from its intersection with County Road 600 West to the eastern incorporated boundary of the Town of McCordsville, Indiana, a distance of approximately 2,569 feet.

## SECTION II

Any person violating this ordinance shall be subject to a fine and/or penalty as set forth in Title VII, Chapter 70, § 71.9 of the McCordsville Code of Ordinances.

### **SECTION III**

This Ordinance shall be in full force and effect from and after its passage and due publication.
