

FOUNDATION DIMENSIONS ARE FROM CONCRETE BLOCK AND
NOT FACE OF STONE

PLAN DIMENSIONS TO MASONRY WALLS ARE ACTUAL WALL DIMENSIONS - ASSUMED BLOCK TO BE 4" WOOD STUD WITH SHEATHING" AND 8" WOOD STUD AND MASONRY VENEER

FIRE EXTINGUISHER AND ELECTRICAL PANELS ARE TO BE 6'-0" ABOVE FINISH FLOOR TO HEAD OF SAME

RAMP ALL CHANGES IN FLOOR ELEVATIONS EXCEEDING 1/4". THIS INCLUDES ALL INTERIOR AND EXTERIOR GRADES FROM PARKING AREAS TO EMPLOYEE AREAS


ADA TOILET ELEV






ENTRANCE ELEVATION




LANDSCAPE PLAN SCALE 1" = 20'


