- Public Works Committee:
 - Discussed the potential CR 600W bridge project.
 - Round-a-bout at CR 600W and CR 600N: The Indianapolis MPO has selected this location as a "high crash" intersection which means it has been designated for correction. The MPOI has safety related funding which will be used for this purpose. Town staff will bring information back to the November council meeting and will be asking the Council for funding support, along with Hancock County RDC support, to help fund this project. This is a five-year design-construction schedule (2025).
 - Town Center Drainage RFP: Staff requested funding from the McCordsville RDC.
 - Stansbury Ditch Project Road Realignment:
 - The cost to realign the road, instead of moving the ditch itself, is just about double (\$600,000).

Public Comments

- Leah Borrmann, resident: Mrs. Borrmann read a statement about the effect of noise. She does not want the current ordinance amended or different decibel levels assigned. She could here Daniel's Vineyard's last event inside her home even though her home was closed up. She said Daniel's has not done the things they said they would do to contain the noise. She wants the Council to understand the location of the vineyard is in the wrong place as it disturbs the environment.
- Blair Borrmann, resident: He said it sounds like the amendment might apply only to the Vail property which he finds a little more acceptable. The original agreement called for four to six events per season. He does not think Daniel's was ever approved to be an outside concert venue. Regarding a special events permit, if Daniel's were to have four to six events per season, he thinks a lot of the homeowners could live with that because they would know in advance when they would be. He said anything else Daniel's hosts could be done inside their facility.
- John Price, resident: Mr. Price asked about the status of the sidewalk that is supposed to be installed in front of Daniel's. Mr. Crum said it is scheduled to be part of the Creekside Trail project which was discussed earlier in the meeting. He asked about the status of the removal of the shipping containers being used for storage on the property since they are still there and there is no current enforcement action. The response was that issue was susended when the Council began to try to work all this out.
- Lyn Holzbach, resident: Ms. Holzbach asked if the distillery was still being planned. The response was that plan has been dropped.
