Sewer Rate Ordinance

- Deen Rogers from Baker Tilly directed the Councilors to page 6 of the Rate Study for the Schedule of Estimated Project Costs and Funding.
 - Mr. Rogers recommends adopting the rate of \$52.99 as introduced. Alternative #2 gives the Town the most flexibility.
 - Mr. Witsman asked the Councilors to bring up the bid summary. Public Works recommended Walsh Construction for the base bid. Boyle Construction did not have any wastewater experience.
 - o Alternative #1 is adding an extra bay to the building in the beginning instead of later.
 - Alternative #2 is adding a Variable Frequency Drive which gives more control of the sledge pumps.
 - Matt Whitaker from Whitaker Engineering stated Alternative 1 will be needed later and dollar per square foot will increase significantly in the future. Alternative 2 is direct cost from the contractor for the pumps which would not go up significantly in the future.
- Ordinance 031020 was read by title by Mr. Morelock.

- Motion by Mr. Strayer to accept base bid plus Alternate 1 from Walsh Construction for \$7,161,000 as the lowest and best responsive bid. Brewer. 5-0
- Motion by Mr. Strayer to authorize Mr. Wood to sign Notice of Award, Agreement, and Limited Notice to Proceed as soon as all documents have been prepared. Brewer. 5-0
- Mr. Brewer asked if the equipment already paid for was added in the construction costs originally. There was a discussion which led to Mr. Rogers recalculating the numbers.

Fire Territory

- Florence May, Vernon Township Trustee, stated the special legislation did not pass and we need
 to move on to Phase 2 which includes a study to research a fire territory structure and financial
 needs.
- Chad Abel, Fire Chief stated there are several gaps in coverage. We have a training budget of zero dollars; we must be very creative to be able to do training now. Trustee May and her staff have aggressively gone after many funding sources. We need to set a tax rate appropriately to be able to sustain operations 24/7 now. We will not be able to keep up with the growth rate.
- Trustee May stated our equipment is very old, majority would qualify for antique plates. She directed the Councilors to Attachment 2 in their packets. Our recommendation is to pursue a fire territory. The packet gives three options.
- Paige Sansone, from Baker Tilly, stated there are very few options in fire service. We have until
 June 30, 2020 to establish a fire territory because the deadline has been extended by the
 Governor. Ms. Sansone went through the process to establish a fire territory. Each Council and
 Board would all have to agree, or the fire territory would not happen.



- Motion by Mr. Brewer in the best interest of the Town of McCordsville to move forward with a fire territory study by Baker Tilly and to pay for professional services not to exceed \$6700.

- Mike Reuter Financial Adviser for Vernon Township was involved with the special legislation and stated a fiscal impact study had already been done with the Buck Creek model for the legislation last fall.

Informal Development Proposal

- Tom Rich from Breedlove Dobbs HVAC made the presentation.
- They would build a 3000 square foot building.
- They would have 5 full time employees on site every day and 5 more employees to pick up supplies and material before going to jobsites.
- The Councilors would recommend a few items to look at closer; more brick, the roof pitch maybe 3/12 with standing seam, and landscape buffers.
