ORDINANCE AMENDING TITLE VII, CHAPTER 72, SCHEDULE I

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore adopted Ordinance No. 121112, An Ordinance Establishing Speed Limits Within The Town Of McCordsville, Indiana; and

WHEREAS, the Town Council of the Town of McCordsville, Indiana, believes that it is in the best interest of the health, safety, and welfare of the citizens of McCordsville, Indiana, that the speed limit on 500 North from its intersection with 600 West traveling westerly 1,336 feet or 0.253 miles the speed limit shall be 45 mph and on 500 North from its intersection with 600 West traveling easterly for 2,417 feet or 0.458 miles the speed limit should be 45 mph.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

SECTION I

Title VII, Chapter 72, Schedule I, shall be amended by the addition of the following:

500 North	Easterly and Westerly	From its intersection with 600 West traveling westerly 1,336 feet or 0.253 miles	45 mph
500 North	Easterly and Westerly	From its intersection with 600 West traveling easterly 2,417 feet or 0.458 miles	45 mph

This Ordinance shall be in full force and effect, from and after its passage, due publication and posting as required by law within the Town of McCordsville, Indiana.
