Amanda Deardorf introduced the Jensen model and the five elevations associated with it. This model is part of the Maple Street Collection.

Mr. Strayer questioned Mr. Crum and Ms. Deardorf about the amount of cement board on the Modern Farmhouse and the stone/masonry requirement for Woodhaven. Mr. Crum informed the Board that the Woodhaven PUD allows 50% of the homes to have no brick, and that while the homes Fischer has built to date all have brick, the previous builder did build a few without. Tom asked about the amount of cement board on the Modern Farmhouse.

Mr. Strayer asked if there was a requirement for a set out. Mr. Crum stated that there is not.

Mr. Crum reviewed his Director's report and asked Ms. Deardorf to confirm that all overhangs are at least nine inches, that the roofs have a 6:12 pitch, and that the windows have 1" x 6" trim. Ms. Deardorf confirmed that all elevations conform to the standards.

Mr. Wood made a motion to approve all the elevations as presented. Ms. Jacobi seconded the motion. The motion passed 4/0.
