Vernon Township Fire Department **Temporary Firefighter Housing** 7580 Form Street

The Vernon Township Fire Department requests a variance to allow a manufactured house to be placed at the existing McCordsville Fire Station to be used for temporary housing of firefighters. A 3-4 person crew will provide fire response and paramedic services to McCordsville 24 hours a day, 7 days a week. VTFD will have the staffing to do this by the fall of 2021. Once the new station is built on 900 N, this crew will be moved to that location and the temporary structure will be removed from the site. The existing fire station will continue as a location to house support staff for VTFD and will be maintained as it is today.

The structure being requested in a new 14x70 manufactured home. The structure is 3 bedroom and 2 bath allowing for personnel to stay overnight. VTFD is investigating two potential locations on the property. The south side of the building is a paved parking lot with easy access to the sewer clean out, water and electric. The north side of the building has a large grass covered lot that has easy access for the for the structure but may have more expense associated with utilities. Either location appears to provide enough space.

VTFD currently staffs Station 431 in Fortville 24 hours a day with an Engine with 3-4 personnel and a Medic with 2 personnel. The McCordsville Station (8) houses 1 engine, 1 rescue, 1 tanker, 1 grass rig and an additional reserve engine. There are no sleeping quarters to allow 24-hour coverage. The Vernon Fire Protection Territory was established to improve fire/EMS coverage to the community. The need for a station in McCordsville was established through that process.

A new station is proposed for McCordsville to be constructed in 2022 north of the railroad tracks. We anticipate occupying the new station by mid to late 2023.

Page two of this document provides data that supports this need.

<u>Summary</u>

- Runs slightly decreased in McCordsville from 2019-2020. Some decrease in run load overall is attributed to the pandemic. However, runs will likely increase at a more rapid rate compared to Fortville due to new housing starts and growth projections.
- To October 23, 2020, 46% of the runs in Vernon Township are in McCordsville. At the time of the variance request, VTFD does not have to date statistics. Anecdotal evidence suggests there is an increase of runs to McCordsville.
- Average response times in Fortville are 2 minutes and 21 seconds faster than McCordsville
- There were consistently more building permits issued in McCordsville than Fortville over the last
- 4 years indicating the growth is faster and the run load will be expected to surpass Fortville.

- Traditions at Brookside and Meijer are the top to run locations for VTFD over the last two years. Both are in McCordsville.
- McCordsville has over a million square feet of commercial space to provide fire protection to.






