#### **New Town Hall Update**

1. Phil Knickhrem from Leo Brown Group LLC told the council that the bids for the rebid items were opened on November 8<sup>th</sup>. The bids that came back and are still outside the budget will need to be studied to see if there is some way to get them back within the budget. He said they cannot discern why the HVAC numbers are so much higher than the estimated numbers.

#### 8038 N. CR 600W Home Conversion Proposal – Roger and David Heir

The proposal by the Heirs is to convert the property into a multi-tenant building. It is currently zoned "Industrial Commercial Park." They will be using the existing footprint but will be rehabbing it. There is an existing curb cut on CR 600W which will be moved to CR 800N. Mr. Witsman told the council that this entrance plan is about the best the town will get with this site.

# **Public Works Committee**

1. Town Standards: Mr. Witsman told the council that the Town Standards are five years old and require updating.

Motion by Mr. Meise that we approve the Professional Services Agreement with Witsman Engineering in the amount of \$8250.00. 2<sup>nd</sup> by Mrs. Williams. Passes 5-0.

2. Pavement Maintenance Plan: The plan is a five year management plan.

Motion by Mr. Meise that we approve the Contract for Engineering Services to Beam, Longest and Neff. 2<sup>nd</sup> by Mr. Barnes. Passes 5-0.

3. Dump Truck Quotes: Mr. Crider received three quotes from Capitol City Ford, Inskeep Ford, and Stanley Chevrolet. The quotes do not include the light kit.

Motion by Mr. Meise that we approve the purchase of the Ford F450 from Inskeep at the price of \$43,449.00 with five yearly payments of \$9,990.00 and this would include the Henderson Mark III steel dump bed.  $2^{nd}$  by Mrs. Williams. Passes 5-0.

#### **New Business**

- 1. Motion by Mr. Meise that we provide the \$50 gift certificate for the employees for Christmas as we have done in the past. 2<sup>nd</sup> by Mr. Barnes. Passes 5-0.
- 2. Mr. Meise said residents have come to him regarding having parking on one side only in Highland Springs and that the restriction could be kept to the two entrance streets. The request will be sent to the Public Safety Committee.

#### **Other Committee Reports**

- 1. 2011 Steering Committee: The committee met for the last time on November 8<sup>th</sup>. They looked at maps and street standards and discussed trees for streets.
- 2. Hancock Solid Waste Board: The board had its final meeting of the year. The board hired a part-time employee to fill what was a full-time position.
- 3. Redevelopment Commission: The commission met October 14<sup>th</sup>. The Farmers Market was discussed as well as the realignment proposal for CR 600W. There will not be a meeting in November.

4. Planning & Zoning Committee: The October meeting included M/I Homes in Gateway Crossing, the Cook Winery proposal and the Craftsman-style home proposed for Geist Woods Estates.

# **Town Manager's Report**

- 1. The request for proposal for planning services for the town has been sent and replies are due November 15<sup>th</sup>. Three firms will be interviewed.
- 2. The request for proposal for trash service for the town has been sent and replies are due December 7<sup>th</sup>. The contract will be awarded at the December 14<sup>th</sup> council meeting.
- 3. The town Christmas Party will be held December 3<sup>rd</sup> from 5:30 p.m. to 7:30 p.m.

# **Public Works Commissioner's Report**

- 1. Terra Lane, Highland Lane and McCord Street resurface contract has been completed.
- 2. IDEM Report: The report on the wastewater treatment plant by IDEM yielded no problematic issues. The plant passed the inspection.

1. Don Vail, resident: Mr. Vail thanked Chief Rodgers for the department's participation in the Halloween festivities at the McCordsville Fire Department. They had 250-300 people go through for trick or treat activities. Mr. Vail suggested the town might want to participate by having something there as well.
