

**ORDINANCE NUMBER: 091206**

**AN ORDINANCE AMENDING ORDINANCE NUMBER 020991A, 071297, 102898A AND 071106A ORDINANCES ESTABLISHING A POLICE ACTIVITY FUND**

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana on March 09, 1991, enacted Ordinance Number 020991A regarding the establishment of a Police Activities Fee Fund, and since then the Town Council has enacted three (3) amendments of said Ordinance; and

**WHEREAS**, within said Ordinance and its subsequent amendment, certain fees were established for the preparation of concealed carry handgun permits; and

**WHEREAS**, since the adoption of said original ordinance and its amendments changes have been made to the fee schedule required by the Indiana State Police for the preparation and processing of applications for concealed handgun permits; and

**WHEREAS**, effective July 1, 2006 I.C. 35-47-2-3 was amended to allow for the creation of a lifetime license to carry a handgun and to change the amounts which a law enforcement agency shall collect for the preparation and processing of the application for said license.

**BE IT THEREFORE ORDAINED** by the Town Council of the Town of McCordsville, Indiana, that:

**SECTION I**

That Section III of Ordinance 020991A, FIREARMS APPLICATION FUND, HANDGUN PERMIT FEE is hereby deleted and inserted in lieu thereof is the following:

**FIREARMS APPLICATION FUND, HANDGUN PERMIT FEE**

There shall be a filing fee of \$10.00 charged by the Town of McCordsville for the purpose of preparing a handgun permit application, either limited or unlimited for licenses that expire four (4) years from the date of issuance, and a filing fee of \$50.00 charged by the Town of McCordsville for the purpose of preparing a handgun permit either limited or unlimited for licenses that have no expiration date (lifetime licenses). There is hereby established a special fund for the receipt of firearms permit application fees, such to be called the "Firearms Application Fund", monies in which shall be used for the purposes of training for the McCordsville Police Department. Upon receipt of an application filing fee for licenses that expire four (4) years from the date of issuance, Five Dollars (\$5.00) thereof shall be immediately allocated to an deposited in the Firearms Application Fund; the remaining Five Dollars (\$5.00) shall be deposited in the Special Deposit Fund and shall be refunded to the applicant if the firearms permit is denied, or shall be transferred to the Firearms Application Fund when the permit is granted. Upon receipt of an application filing fee for licenses that that have no expiration date, and the applicant has a current license to carry a handgun, Ten Dollars (\$10.00) thereof shall be immediately allocated to an deposited in the Firearms Application Fund; the remaining Thirty Dollars (\$30.00) shall be deposited in the Special Deposit Fund and shall be refunded to the applicant if the firearms permit is denied, or shall be transferred to the Firearms Application Fund when the permit is granted. Upon receipt of an application filing fee for licenses that that have no expiration date, and the applicant does not have a current license to carry a handgun, Twenty Dollars (\$20.00) thereof shall be immediately allocated to an deposited in the Firearms Application Fund; the remaining Thirty Dollars (\$30.00) shall be deposited in the Special Deposit Fund and shall be refunded to the applicant if the firearms permit is denied, or shall be transferred to the Firearms Application Fund when the permit is granted.

**SECTION II**

Introduced and filed on the 12<sup>th</sup> day of September, 2006. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 4 in favor and 0 opposed pursuant to I.C. 36-5-2-9.8.

Duly ordained and passed this 12<sup>th</sup> day of September, 2006 by the Town Council of the Town of McCordsville, Hancock County, Indiana, having been passed by a vote of 4 in favor and 0 opposed.
