ORDINANCE NO. 061218

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY CHANGING AND EXTENDING THE CORPORATE BOUNDARIES OF THE TOWN OF MCCORDSVILLE, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF MCCORDSVILLE, INDIANA THAT:

<u>Section I.</u> The corporate boundary of the Town of McCordsville, Indiana is hereby changed and extended so as to include and make a part of the corporation of the Town of McCordsville, Indiana, the following described real estate situated in Hancock County, Indiana, consisting of 81 acres, more or less, including right of way, described on "Exhibit A", attached hereto and incorporated herein by reference.

Section II. The Town of McCordsville, Indiana has developed a fiscal plan and has established a definite policy to furnish the annexed territory within a period of three (3) years, governmental and proprietary service substantially equivalent in standard and scope to the areas of the Town which have characteristics of topography, patterns of land utilization and population density similar to the above-described property.

<u>Section III.</u> The annexed territory west of County Road 600 West is hereby assigned to Council District 1.

<u>Section IV.</u> This Ordinance shall be in full force and effect from and after its passage, approval by the Town Council, and publication as prescribed by law.

<u>Section V.</u> The annexed territory to be zoned "PUD: Planned Unit Development" is described in attached "Exhibit A", and commonly referred to as Weavers Landing.

<u>Section VI.</u> Introduced and filed on the <u>12th</u> day of <u>June</u>, 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 5 in favor and 0 opposed pursuant to I.C. 36-5-9.8.

Duly ordained and passed this 11th day of September, 2018 by the Town Council of the Town of McCordsville, Hancock County, Indiana, having been passed by a vote of 1 in favor and 1 opposed.
