

ORDINANCE NO. 081418-B

**ORDINANCE AMENDING TITLE VII, CHAPTER 72, SCHEDULE II**

**WHEREAS**, upon the recommendation of the Public Works Committee, the Town Council of the Town of McCordsville, Indiana, has been advised of the need to amend Title VII, Chapter 72, Schedule II to add to the schedule of intersections; stop signs, regulations regarding the intersection of Woodhaven Drive and Woodhammer Trail; and

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana, believes the creation of a 4-way stop at the intersection of Woodhaven Drive, Woodhammer Trail and N. Woods Edge Drive is in the best interest of the citizens of McCordsville, Indiana.

**THEREFORE BE IT ORDAINED** by the Town Council of the Town of McCordsville, Indiana, as follows:

**SECTION I**

Title VII, Chapter 72, Schedule II, is hereby amended by the addition of the following:

Direction(s)	Street/Road	Intersection
Northbound and southbound	Woodhaven Drive	At its intersection with Woodhammer Trl. and N. Woods Edge Dr.
Westbound	Woodhammer Trail	At its intersection with Woodhaven Dr. and N. Woods Edge Dr.
Eastbound	N. Woods Edge Dr.	At its intersection with Woodhaven Dr. and Woodhammer Trl.

**SECTION II**

This Ordinance shall be in full force and effect from and after its passage and due publication according to law.

**SECTION V**

Introduced and filed on the 14<sup>th</sup> day of August, 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 5 in favor and 0 opposed pursuant to I.C. 36-5-2-9.8.

Duly ordained and passed this 14<sup>th</sup> day of August, 2018 by the Town Council of the Town of McCordsville, Hancock County, Indiana, having been passed by a vote of 5 in favor and 0 opposed.




