

**ORDINANCE NO. 111318B**

**AN ORDINANCE CONCERNING A TRASH COLLECTION UTILITY FUND  
FOR THE COLLECTION AND DISBURSEMENT OF TRASH COLLECTION  
AND USER FEES IN CONNECTION WITH THE TRASH COLLECTION  
UTILITY SYSTEM FOR THE TOWN OF McCORDSVILLE, INDIANA**

**WHEREAS**, the Town of McCordsville, Indiana, has enacted an Ordinance establishing a trash collection utility and user fees to be collected from the users and owners of properties served by the trash collection utility system within said Town; and

**WHEREAS**, in accordance with the Indiana Code Provision 36-9-23 governing trash collection systems and the collection of fees the Town Council of the Town of McCordsville, Indiana, finds it is necessary to establish a fund for the financial wellbeing of said trash collection.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF McCORDSVILLE, INDIANA**, as follows:

**SECTION I**

There is hereby established a McCordsville Trash Collection Fund.

**SECTION II**

That the User Fees collected in accordance with Ordinance No. 111318A establishing fees and any amendments thereto are to be deposited in said fund with the revenues retained, accumulated, and used for improvements of the Trash Collection Utility System as permitted by Indiana Code 36-9-23 and as directed by the Town Council.

**SECTION III**

That the Fund shall be established and administered in accordance with the purpose set forth by the Town Council for the Town of Ingalls and in accordance with State Law and Compliance with the State Board of Accounts.

**SECTION IV**

This Ordinance shall be in full force and effect from and after its passage and publication as prescribed by law.

**SECTION V**



**TOWN OF McCORDSVILLE, INDIANA, BY ITS TOWN COUNCIL**




