

**ORDINANCE NO. 121918**

**ORDINANCE TO AMEND ORDINANCE NO. 111318A**

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana, has heretofore passed Ordinance No. 111318A regarding, in part, the terms and provisions of Trash Collection Service to residential customers of the Town Sewer Utility or the Town Storm Water Utility; and

**WHEREAS**, upon further review of said Ordinance, by members of the billing staff, certain amendments to the terms and provisions of said Ordinance have been recommended; and

**WHEREAS**, the Town Council of the Town of McCordsville, Indiana, believes such amendments are in the best interest of the efficient management of the trash collection service, as well as in the best interest of the citizens of McCordsville, Indiana.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF McCORDSVILLE, INDIANA**, as follows:

**SECTION I**

SECTION II (b) shall be deleted in its entirety and inserted in lieu thereof shall be the following:

(b) The Trash Collection Fee may be billed to the tenant or tenants occupying the property served only upon the written request of the property owner and the acknowledgment of the property owner that the property owner remains liable for any and all outstanding and unpaid charges to the address and service may be terminated if the property owner does not pay the statement, even if the charges were under the tenant's name.

**SECTION II**

SECTION II (d) shall be deleted in its entirety and inserted in lieu thereof shall be the following:

(d) All Trash Collection Fees not paid by the 15<sup>th</sup> day of the month following receipt (the "Due Date") are hereby declared to be delinquent and a penalty of ten percent (10%) of the delinquent balance shall be added to the Trash Collection Fees due.

**SECTION III**

SECTION II shall be amended by the addition of provision (e) to read as follows:

(e) Payments received from the sewer customer and/or storm water customer shall be applied first to Trash Collection Services, second to Storm Water Utility Fees and thirdly to Sewer Utility Fees.

**SECTION IV**

This Ordinance shall be in full force and effect from and after its passage and publication as prescribed by law.

**SECTION V**


Introduced and filed on the 19<sup>th</sup> day of December 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 4 in favor and 0 opposed pursuant to I.C. 36-5-2-9.8.

Duly ordained and passed this 19<sup>th</sup> day of December, 2018, by the Town Council of the Town of McCordsville, Hancock County, Indiana, having been passed by a vote of 4 in favor and 0 opposed.






