**RESOLUTION ESTABLISHING ORDINANCE VIOLATIONS BUREAU**  
**SCHEDULE OF FINES**

**WHEREAS**, the Town Council of the Town of McCordsville, Hancock County, Indiana, has heretofore adopted Ordinance No. 081412C, establishing an Ordinance Violations Bureau, a Schedule of Ordinances Subject to Admission of Violation and a Scheduled of Fines; and

**WHEREAS**, pursuant to Section III of said Ordinance, the Schedule of Fines and Penalties are to be reaffirmed and/or amended annually by Resolution in January of each calendar year as deemed appropriate by the Town Council of the Town of McCordsville, Indiana; and

**WHEREAS**, being duly advised, the Town Council of the Town of McCordsville, Indiana, hereby reaffirms the current Schedule of Fines and Penalties to be imposed for violations subject to admission through the McCordsville Ordinance Violations Bureau as set forth below.

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Council of the Town of McCordsville, Indiana, as follows:


