

ORDINANCE NO. 121019B

ORDINANCE AMENDING ORDINANCE 121112
ESTABLISHING SPEED LIMITS ON COUNTY ROAD 900 NORTH

WHEREAS, the Town Council of the Town of McCordsville, Indiana, has heretofore adopted Ordinance No. 121112, An Ordinance Establishing Speed Limits Within The Town Of McCordsville, Indiana; and

WHEREAS, commencing January, 2020, a new school shall be open for educational purposes at the intersection of County Road 600 West and County Road 900 North; and

WHEREAS, upon the recommendation of staff and the McCordsville Police Department, the creation of a special school zone speed limit in the area of the new institution is in the best interest of the health, safety, and welfare of the citizens of McCordsville, Indiana.

THEREFORE BE IT ORDAINED by the Town Council of the Town of McCordsville, Indiana that:

SECTION I

Ordinance No. 121112, SECTION XXVII, is hereby amended to read as follows:

Vehicles traveling Eastbound or Westbound on County Road 900 North commencing at a point that is 50 West of its intersection with County Road 600 West, and extending for a distance of 840 feet West of said point of beginning, shall not travel at a speed in excess of 25 mph when the lights on specially installed signage is flashing indicating that school is in session.

SECTION II

Ordinance No. 121112 is hereby amended by the addition of SECTION XXVIII to read as follows:

This Ordinance shall be in full force and effect, from and after its passage, due publication and posting as required by law within the Town of McCordsville, Indiana.

SECTION III

Introduced and filed on the 10th day of December, 2019. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of 5 in favor and 0 opposed pursuant to I.C. 36-5-2-9.8.

Duly ordained and passed this 10th day of December, 2019 by the Town Council of the Town of McCordsville, Hancock County, Indiana, having been passed by a vote of 5 in favor and 0 opposed.
